## **DISABLED VETERAN EXEMPTION**

The real property of any veteran with a 100-percent service-connected, permanent, and total disability may be exempt from taxation. This also extends to the surviving spouse of a veteran who died on or after January 1, 2011.

## **MILITARY MEMBER KILLED IN ACTION EXEMPTION**

The real property of the spouse of a member of the armed forces killed in action may be exempt from taxation. The exemption applies only to taxes paid on or after January 1, 2015, and if the spouse has not remarried.

## **REAL ESTATE TAX RELIEF**

### ***You may be eligible for real state tax relief if:***

- The property in Arlington is your primary residence, and
- You are at least 65 years of age or totally and permanently disabled, and
- Your annual income and your assets fall within certain limits.

Eligible homeowners receive a full exemption, partial exemption, and/or deferral based on their income and assets.
