## REAL ESTATE TAXES

The tax rate that will apply to the new assessed value has not been established. Arlington County Board will hold a public hearing on the 2024 real estate tax rates on April 4, 2024, at 7:00 p.m. The County Board will adopt the 2024 real estate tax rates on April 20, 2024. The adopted rates determine the amount of taxes levied for the year. Real estate taxes are billed by the Arlington County Treasurer in two installments (due June 15 and October 5). If you request a review by the Department of Real Estate Assessments or appeal to the Board of Equalization, the dates taxes are due does not change.

## DEPARTMENT ASSESSMENT REVIEWS

Property owners may request that an appraiser review an assessment by filing an application. Applications for review must be delivered, postmarked, or filed online before midnight on March 1, 2024

## **BOARD OF EQUALIZATION APPEALS**

Property owners who are not satisfied with the assessment review may appeal to the Board of Equalization. Applications must be delivered, postmarked, or filed online before midnight on April 15, 2024.

## DISABLED VETERAN EXEMPTION

The real property of any veteran with a 100-percent service-connected, permanent, and total disability may be exempt from taxation. This also extends to the surviving spouse of a veteran who died on or after January 1, 2011.

## MILITARY MEMBER KILLED IN ACTION EXEMPTION

The real property of the spouse of a member of the armed forces killed in action may be exempt from taxation. The exemption applies only to taxes paid on or after January 1, 2015, and if the spouse has not remarried.

## REAL ESTATE TAX RELIEF

# You may be eligible for real state tax relief if:

The property in Arlington is your sole residence, and You are at least 65 years of age or totally and permanently disabled, and Your annual income and your assets fall within certain limits.

Eligible homeowners receive a full exemption, partial exemption, and/or deferral based on their income and assets. Forms and assets/income limit information for 2024 will be available in February.
